Capital Reserve Study

An update to UCI's capital reserve study was conducted in 2023. It was based on prior studies conducted by capital reserve consultants MillerDodson in 2012 and 2016. The reports from these studies, along with an additional one from a study done in 2018 by another firm, are available for review under "Financial" in the members section of www.Ulmstead.org.

Note the Barn was intentionally left out of this update due to the separate renovation project. The study will be updated again when that project is complete. While the study methodology is not perfectly-suited to UCI's facilities, we worked with MillerDodson to amend the approach to better meet UCI's needs.



New UCI Treasurer For 2024 and Beyond!
