Slip Selection

Slip selection will be held on Saturday March 14, 2026 at **DOCK 2**. Gates will open at 9 a.m. and slip selection will begin promptly at 930 a.m. Last year's preregistration greatly sped up the process, and we were finished in an hour, so do not be late. Beginning this year, all registrations (boat slips, small boat stickers, and trailer stickers) are on one form and must be completed online. **There are no paper forms this year.**

The registration form will be located in the Nautical section of the Members Only page of the UCI website (Ulmstead.com) beginning February 14. If you do not have access to the Member's Only page, contact UCI Membership at membership@ulmstead.org to register. Failure to complete the preregistration online prior to slip selection will delay your registration process and may impact your priority in selecting a slip.

Any issues regarding slip selection, nautical priority, vessel ownership, and insurance must be addressed before March 7 by contacting Bill Zichos at dockmaster@ulmstead.org. During slip selection fees may be paid with credit cards or checks. After slip selection all fees must be paid with a check. As always, no cash. A 3% transaction fee will be added to all credit card purchases.

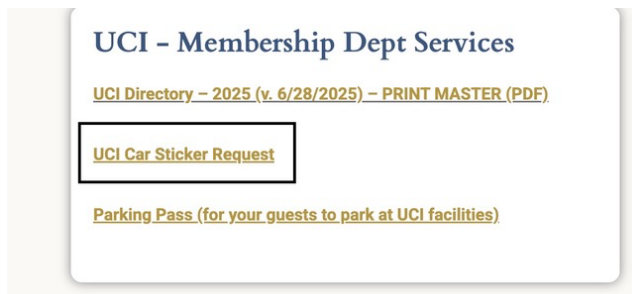
